## Screening test VOC/SVOC

The net has also been examined according to the above mentioned screening test (volatile organic compounds and semivolatile organic compounds) the test results are complying with the law and regulations in the following conditions:

Extraction solvent: HEXANE:ETHANOL 3:1

Time and temperature of extraction: 8 hours at 20°C

The computations have been arranged assuming that 1 kg of food comes in contact with 10 dm<sup>2</sup> of packaging material.

The simulating substance and the test conditions are chosen in accordance with Regulation EC 10/2011 and amendments (Regulation EU 1245/2020)

The material **doesn't contain** "dual use" substances.

It is the responsibility of the user of the material intended to come in contact with foodstuff, to communicate to our company possible restrictions regarding the components (presence of additive and aromas) of the food that must be packed.

This declaration is valid after the below date 24 months, and it will be previously replaced in case of changes in the production/formulation of the material, or if the law references will be revised and updated so that a new compliance checking is required.
