3. Description and raw material of the product

The product, Oil/vinegar sprayer with spout GrandCHEF 250 ml, consists of plastic cover in dark green colour (acrylonitrile-butadiene-styrene) (ABS). Plastic lid in dark green colour made of polypropylene (PP). Plastic sealing in white colour made of poly(ethylene vinyl acetate). Plastic head of sprayer in black colour made of polypropylene (PP). Plastic in blackhead in white colour poly(oxymethylene). Colourless plastic roller, plastic lid on the roller, plastic in metal spring made of polypropylene (PP). Colourless plastic tube made of polyethylene (PE). Metal spring made of stainless steel material. Clear glass bottle.

All plastics parts used in this product are "BPA free"



4. Purpose of the product

Food category:

The product is suitable for all kinds of foodstuffs: acetic (pH <4,5), milky, oily.

Max. time / temperature of use:

The product is intended to come into a long-term contact with a foodstuff: max. 10 days at temperature up to 40°C.
